Current Environment

Interest rates have been in a secular decline since the early 1980's and remain at historically low levels. Given this low interest rate environment investors have been forced to look for alternative sources to produce income in their investment portfolios. Increasing income in today's environment comes with additional risks such as lowering the quality, increasing duration, or looking to an additional asset class beyond traditional fixed income securities altogether.

Potential Solution

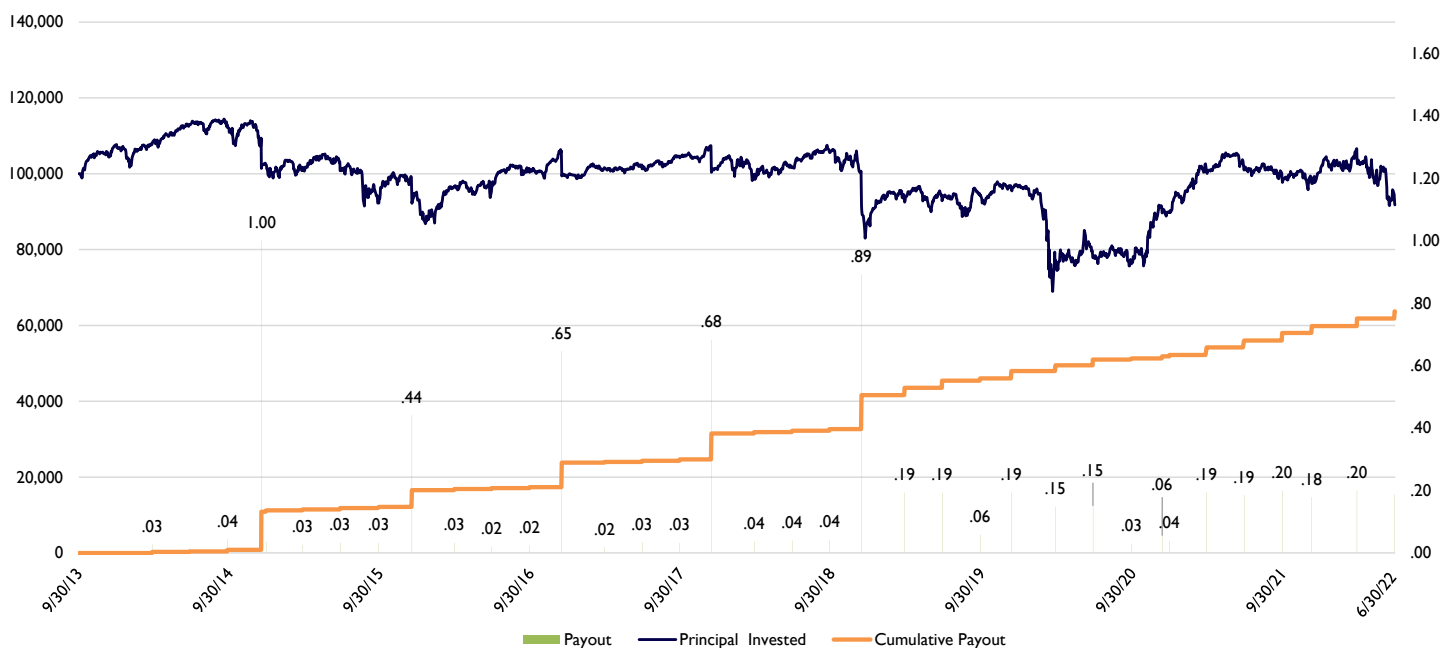
The Covered Bridge Fund (TCBIX) was created with the primary objective of generating income by purchasing large capitalization dividend paying securities and writing covered calls on approximately half of each position.

- Dividend paying stocks which we believe are high quality.
- Call options sold on existing positions.
- Index put options purchased in extreme cases with the goal of protecting the principle of the fund.

Important Definitions: Call Option: An agreement that gives an investor the right (but not the obligation) to buy a stock, bond, commodity or other instrument at a specified price within a specific time period. Call options involve risks different from, or possibly greater than, the risks associated with investing directly in securities and other traditional investments. Put Options: An option contract giving the owner the right, but not the obligation, to sell a specified amount of an underlying security at a specified price within a specified time. Covered Call: An options strategy whereby an investor holds a long position in an asset and writes (sells) call options on that same asset in an attempt to generate increased income from the asset. This is often employed when an investor has a short-term neutral view on the asset and for this reason holds the asset long and simultaneously has a short position via the option to generate income from the option premium. Option Premium: The income received by an investor who sells or "writes" an option contract to another party.
