

Fund Overview

The Covered Bridge Fund was created with the goal of reducing risk during equity market volatility and extending income opportunities for investors.

Fund Objective

The fund seeks current income and realized gains from writing options with capital appreciation as a secondary objective.

- Dividend paying stocks which we believe are high quality.
- Call options sold on existing positions.
- Index put options purchased in extreme cases with the goal of protecting the principle of the fund.

Fund Method

Seek to provide above average equity **income** generated from dividend paying large cap value stocks and premium collected from writing covered calls. We believe writing covered calls on approximately half of each position could provide **reduced risk** to a portfolio by showing lower volatility over the long term. Leaving approximately half of each individual position uncovered can allow for **growth**.
